CITY OF HANCOCK RECREATION COMMISSION September 12, 2017 meeting minutes

A regular meeting of the City of Hancock Recreation Commission was called to order by Chairperson John Haeussler at 6:06 PM at City Hall, 399 Quincy Street, Hancock, Michigan.

Present: Members Crissy Gerhart, John Haeussler, Bill Marlor, Amanda McConnon, and Dan Seguin.

Absent: Members Glenn Anderson, John Diebel, Kevin Kalinec, and Jason Parker.

The Commission welcomed new member Amanda McConnon.

The agenda was unanimously approved (Marlor, Gerhart).

The minutes of the July 11, 2017 regular meeting were unanimously approved (Seguin, Gerhart).

There was no public comment during the public comment session.

The Commission:

- Heard that the \$294,000 DNR beach dock grant award has been signed; plans still need to be submitted and approved by the DNR; City is hoping to bid out project in December or January.
- Reviewed the Campground revenue summary; June and July posted record highs.
- Heard that the poly sheets for the Laurn-Grove dashers have arrived; installation was intended
 for September, but recent, significant unscheduled work has altered the DPW schedule;
 Member Seguin will explore the possibility of assembling a volunteer work force to assist.
- Reviewed the City's new Driving Park Advertising Policy.
- Reviewed the final selection of playground equipment for Montezuma, Terrace, and Third Street Parks; City remains hopeful that two sets will be installed in October; at least one set will be installed next spring.

A motion of support and appreciation for the new swing sets donated by Leah Inman, Josh Penn Boris, and Matthew Boris, for Hancock Beach, Pine Park, and Porvoo Park was unanimously approved (Marlor, Seguin).

In other business, the Commission discussed:

- The base landscaping, led by Barry Givens, has been completed for the Schaaf-Givens sign at Driving Park.
- Naming the hardball field at Driving Park in 2018; recommendations are encouraged.
- Potential improvements to Klondike Park; suggestions include a picnic pavilion; a large Christmas tree; and art installations.
- Recommendations for capital improvements to be included in the City's proposed 2018-19
 recreation budget are sought; can be brought to upcoming meetings; desire to have proposal
 for City Council in spring.
- Enhanced electrical service for the Houghton County Fair is potentially in (geographical) conflict
 with the new batting cages at the hardball field at Driving Park; Member Haeussler will followup with the City Manager; also will attempt to determine if there is any conflict with the
 proposed location of the bocce ball facility.

- The Bike and Pedestrian Committee is working on recommendations for signage throughout the City; if costs exceed the \$4,000 allocated in the 2017-18 recreation budget this is a candidate for additional funds in the next fiscal year; ideally signage will include how to access local ski trails as well.
- The concrete star in (Lower) Montezuma Park has been uncovered and is ready to receive
 plantings; Members Gerhart and Haeussler will continue to research the history of the star and
 the veterans' memorial.

The Commission has tentatively re-scheduled its next regular meeting for Tuesday, November 7, 2017, at 6:00 PM, at Hancock City Hall. Member Haeussler will confer with the City Manager to finalize the schedule. All members will be notified and a meeting notice will be posted at City Hall.

A motion to adjourn at 7:23 PM was unanimously approved (Marlor, Seguin).

PORTAGE LAKE MULTI-EDUCATIONAL SERVICES, INC AND THE CITY OF HANCOCK AGREEMENT FOR SERVICES RENDERED


This agreement for services rendered made on October 18, 2017 between the Portage Lake Multi- Educational Services, Inc. (PLMES), 1500 Birch St., Hancock, MI 49930 and the City of Hancock (City), 399 Quincy St., Hancock, MI 49930 to provide the PLMES with a total of \$60,000 payable over five (5) city fiscal years at \$12,000 per year and PLMES providing services rendered to enhance the city's recreation offerings to its residents.

The following terms and conditions will apply:


- 1. The City will make five (5) annual payments to the PLMES at \$12,000 per year beginning in FY 17/18, and will continue with the FY's 18/19, 19/20, 20/21 and 21/22. Generally, the payments will be made in October of each year out of the City's .8 mill recreation millage fund, which was implemented on July 1, 2017.
- 2. For the payment of \$60,000, the PLMES agrees to provide to City residents free public skating a minimum of two hours per week during the regular ice rink season, generally lasting up to 26 weeks per year. Initially, the open skating hours will be starting at noon on Wednesday's and Friday's, although this schedule can be modified by the PLMES upon notification to the City of Hancock, as long as the minimum two (2) hours is maintained per week at an equal or better time slot.
- 3. For this agreement, the City and PLMES value the per season public skating hours at \$8,500 with an inflation factor included in this amount.
- 4. The PLMES agrees to provide two hours per week during the regular ice skating season for a period of seven (7) years starting with the 2017/18 ice skating season.
- 5. In the event of scheduled hockey tournaments, equipment failure, or other events that limit the agreed to public skating hours, the PLMES agrees to make reasonable accommodations to reschedule the hours.



The Michigan Department of Environmental Quality, Water Resources Division has posted the following notice to our internet home page.

The City of Hancock, Attn: Glenn Anderson, 399 Quincy St, Hancock, MI 49930, has applied to this office for a permit under authority of Part 301, Inland Lakes and Streams of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA). The applicant proposes to install 195 lineal feet of 10-foot wide T-shaped dock with approximately 8 cubic yards of concrete abutment and place approximately 35 cubic yards of riprap along the shoreline. The applicant also proposes to install a seasonal kayak launch adjacent to the pier. The purpose of the proposed project is to provide better facilities at the City's beach and to provide a recreational pier that will allow for recreational activities like fishing, swimming, and kayak launching. The project is located in T55N, R34W, Section 28, Hancock, Houghton County, Michigan.
