Councilor Haeussler publicly apologized to Mayor McKenzie and Councilor Belej and City Attorney Kevin Mackey, he didn't leave his frustration at the door. He also apologized to everyone at the meeting. He thanked the City Council for the chance to salvage the negotiations with Mr. Givens.


Motion by Councilor Blau and supported by Councilor Belej to adjourn the council meeting at 6:53 p.m.
