   Lahti/Carmody property is to be liquidated by October 2022 for taxes. Value of the property is not known at this time. Jim Lahti is considering sale, not easement.
   The purchase would ensure public access along the trail for hiking, walking, biking, fishing, a small park formation and a safer route to Hancock Beach. Money from the DDA could be used for DNR leverage funds. This proposed land purchase for public use in the DDA district falls in
