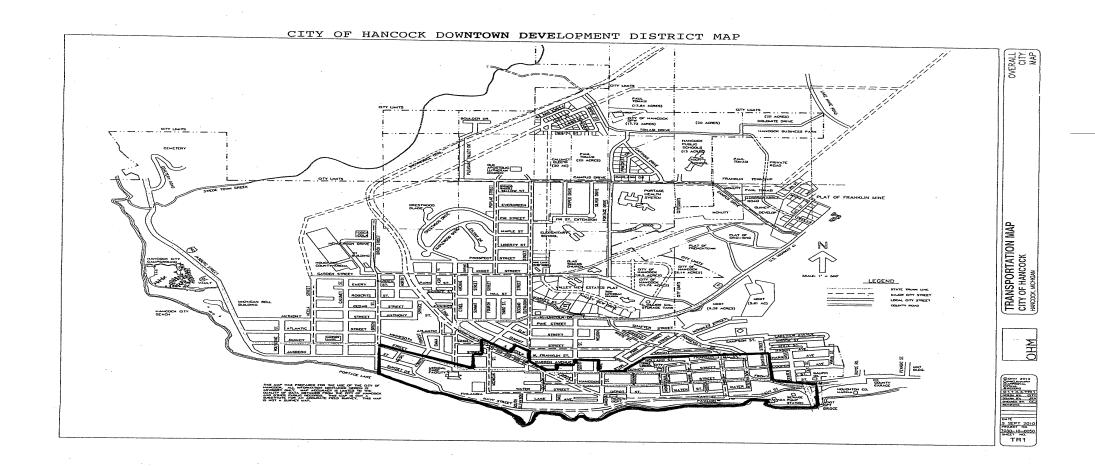
Current plan was an amendment to the 1993 plan and approved by the City Council on December 17, 2014
