ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Hancock 2022 Sewer Improvements** will be received, by the **City of Hancock**, at the office of the **City of Hancock, 399 Quincy Street, Hancock, Michigan 49930**, until **2:00 p.m.** local time on **Friday, April 21, 2023**, at which time the Bids received will be opened and read aloud.

Bids should be mailed to the City Office whose address is above. The bid shall be enclosed in a separate mailing envelope with the notation "SEALED BID ENCLOSED" and the bid shall be in a sealed envelope which indicates the Project Name and Bidder Name.

Bids may also be hand delivered to the City Office prior to the bid opening by appointment only. Contact Mary Babcock at (906) 482-1121 to schedule a bid drop off. The same reference to bid packages as indicated above also applies to bids being hand delivered.

Prior to the time and date designated for receipt of Bids, any Bid that has been submitted may be modified or withdrawn via email to manager@cityofhancock.net or facsimile at (906) 482-7910. Such notice shall be in writing over the signature of the Bidder. Written confirmation over the signature of the Bidder shall be received, and date – and time-stamped by the receiving party on or before the date and time set for receipt of Bids. A change shall be so worded as not to reveal the amount of the original Bid.

The Project consists of Sanitary sewer main line trenchless rehabilitation, sanitary sewer main line spot repairs, sanitary sewer replacement, storm sewer replacement, sanitary sewer manhole installation, sanitary sewer manhole renovation, storm manhole installation and associated surface restoration work at various locations within the City of Hancock.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with deductive alternate bid items as indicated in the Bid Form.
