Section 2. Such supplement shall be deemed published as of the day of its adoption and approval by the City Council and the Clerk of Hancock is hereby authorized and ordered to insert such supplement into the copy of the Code of Ordinances kept on file in the Office of the Clerk.

Section 3. This ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, and shall take effect at the earliest date provided by Charter.
