The location of the 1936 water transmission line is depicted on the Water Main Easement Sketch prepared by OHM, dated November 9, 2011, a copy of which is attached hereto and incorporated herein by reference.
- 2. The City of Hancock further assigns all easements that the City may have to lay, operate and maintain the aforesaid water transmission line, which easements are identified in the "index of Easements" set forth in the aforesaid Water Main Easement Sketch.
