Post REAC Inspection work orders and follow up paperwork has been completed and we earned a 94 out of 100 score. Annual PHA apartment inspections will begin next week. This is part of the annual recertification process that we conduct with each Resident at Lakeview Manor and Annex. Maintenance Staff will be working on the grounds to clean up sand on the sidewalks and parking areas along with general grooming of the property. Rehabs continue in several units and we are at a total of 41 smoke free units to date.

Directors Report:

Section 8 Rental Assistance program has 33 vouchers issued and there are no vacancies at Lakeview Manor.

HUD is in the process of implementing a new reporting tool called EPIC (Energy and Performance Information Center) which will replace our current RAMPS module. This will consist of Capital Fund grant dollars reporting on a quarterly basis.
