The City of Hancock is implementing a cell phone policy to try and meet the Federal IRS policy regarding cell phone provided by a municipal employer. The City of Hancock may issue phones to the following, upon approval of the City Manager:

City Manager, City Clerk/Treasurer, DPW Director, Police Chief, Water Department, Police Department, Transit, Campground and back-up phones for special use or to replace a current phone that is being repaired.

The City Manager, Director of Public works and Police Chief are entitled to phones with e-mail/internet access and a \$100 one-time allowance to purchase a phone. All other cell phone users will pick the free phones offered by the cell phone company. If an employee would like to upgrade their phone or phone service, they must pay for the extra charges. Any additional monthly charges besides the basic rate will be charged to the employee.

The IRS rules state that if municipal government provides employees cell phones for business purposes and allows personal calls, then the employee must pay a pro-rata share of the monthly charge for the personal calls. If we do not do this, the fair market value of the phone plus the monthly service charge is taxable income to the employee reportable on the W-2 form. In order to try and satisfy this requirement, if an employee wishes to make personal calls from this cell phone then there will be a \$10 charge per month to the employee which will be deducted from their paychecks.
