Dave Lucchesi, owner of Bruno's Motors, 612 Quincy St., is requesting a business assistance grant to help defray the cost of demolishing a blighted house located at 621 Hancock Street he recently purchased. The property will allow him to expand his vehicle lot display area along Hancock Street. The estimate provided by Ziemmick Excavating Inc. of Lake Linden is for \$20,000, plus Lucchesi had to pay for the removal of the asbestos siding.

It was moved by Mackin and seconded by K. Johnson to approve up to 50% or a maximum of \$10,000 for a business assistance grant to remove a blighted building located at 621 Hancock Street to make room for business vehicle display area.

Thomas Vichich, President, Society of St. Vincent De Paul, 204 Quincy Street, was present to request grant assistance to help defray the cost of asbestos abatement at the recently acquired adjacent building, the Janis Building, 206 Quincy Street. The building was purchased to allow store and food pantry expansion. He estimated the cost of abatement at \$5,000.

It was moved by Mackin and seconded by Luse to approve a business assistance grant of 50% up to maximum of \$2,500 for asbestos abatement for the building located at 206 Quincy St. owned by St. Vincent De Paul for business expansion purposes.
