Reviewed and Discussed:

- 1. Glenn announced that the Employee City Picnic is set for Friday, August 18th at 1:00 p.m. It will be held at the Beach Pavilion
- 2. Tezcuco Street, to go back to what it was pre-construction
- 3. Bump out curbs taken out and made flat, one by Sounds and Motion on Reservation St. and one by City Hall on Quincy St.
- 4. Joe Pizzi leaving the city after 16 years to work for the Houghton County Sheriff Dept. Wishing him the best.
- 5. City is getting a quote for painting the Front St. Wall
- Joel Evilsizer, Lead Driver, is going to be attending the MI Public Transit Conference, August 22nd through August 25th. RTAP money will pay for almost 100% of the trip.
- 7. Charter Communication Franchise fee
- 8. Some complaints on why a part of White St. had to be dug up after it had just been paved. 301 White St. -water had been shut off for years because of a break in the service line. Contractor had to dig up in order to fix the broken line.
- 9. La Cantina Restaurant's business is picking up since the construction is finished
- 10. Little Brothers is celebrating their 35th Anniversary
- 11. Jeff Lang, CEO of Portage Health-Hancock has resigned and will be moving to Oregon. Roy Vinson is the Interim CEO. Jeff's vacancy on the DDA Board will be filled when the hiring of the new CEO is complete.
- 12. Chief Butler is on National Guard duty in North Carolina
- 13. City has been enforcing the junk car ordinance, if they are abandoned, they are towed, otherwise, people move them themselves
- 14. In September the City will be honoring 2 police officers for life saving.
- 15. City will also be honoring Stephen Smith for his work with the Key Ingredient Event.
- 16. Glenn will be gone on vacation from August 29th September 13th, 2017
- 17. Airbnb inquiries in the city. Eight are listed in the City of Hancock. The City of Marquette just adopted an ordinance that says there can be one per block. John Haeussler stated that there is House Bill #4503 that the council can review. Add to the agenda tonight for discussion.

- 18. Isle Royale Sea Plane concerns-The Isle Royale Superintendent let the owner of the seaplane know of the citizen's concerns. They changed out some props on the plane to help quiet it down
- 19. John Zurcher would like to see the cemetery roadways get paved. May be a possibility next year. This item should be brought up to the Cemetery Board for their review
- 20. John Haeussler informed the council about the Charter Communication's franchise fee. He spoke with Don Gladwell of Charter, he said it is a 10 year contract. It must be approved 30 days from receipt of the letter. This fee is for the use of our right-of-way. We collect a 3% franchise fee from customers. Ted suggested that Glenn send an email to other city managers to see what they collect.
- 21. Paul LaBine reviewed the City of Hancock Driving Park Advertising Policy, dated August 16, 2017 with the council. The Hancock School Girl's Softball Team wants to sell advertising , \$1,000 for a 3 year commitment. Make two changes on the policy. One) #3. Second paragraph down, change semi-colon to a period and Two) #3 c.) Have it say, "Advertising shall be installed **and removed** by the Ad Seller without damaging Park property beyond the minimum necessary to install the advertising material;
- **22.** Discuss 810 Lake Ave. complaint with Cindy Hinkel (805 Lake Ave.) and Keith Butler (803 Lake Ave.)

-Concerned that there is a zoning violation at 810 Lake Ave., 7-9 cars parked there, this is zoned R-1. Three unrelated people constitute a family. The residents of 810 Lake Ave. park in Cindy's driveway and block her driveway. Keith Butler, 803 Lake Ave., addressed the Council and read a letter he wrote while Cindy passed out pictures of the cars involved in the complaint. Scott Hueter from 735 Lake Ave. addressed the Council with concerns of people recklessly driving on Lake Ave. Asked what a definition of One-Family is?? It was concluded that Glenn will draft a letter with the help of the City's Attorney, Kevin Mackey and Glenn will keep in touch with Cindy Hinkel.
