Resolution 21-20

Supporting State and Local Partnerships in Commitment for Materials Management

Whereas, the Michigan Department of Environment, Great Lakes, and Energy has been working with a wide range of stakeholders to substantially update and amend Part 115, Michigan's solid waste statute, to prioritize sustainable materials management, specifically the recovery and diversion of discarded materials for productive use;

Whereas, the City of Hancock's solid waste plans, practices, and contracts require routine updates to incorporate best practices for materials recovery, health and safety for waste handlers, economic analysis, environmental considerations, and community priorities;

Whereas, funding, provided by the state, to facilitate a new planning process in which all pertinent local stakeholders would work to update the city's plan to synergize with regional systems to be designated as Materials Management Plans, reflecting the shift in priorities to reduce the disposal of resources;

Whereas, Part 115 updates aim to support sustainable materials management methodologies such as recycling, composting, anaerobic digestion, and other beneficial utilization activities, by:

- Incentivizing local governments to set recycling goals and plan for holistic discards management.
- Consider and plan for the development of facilities necessary to manage these materials in ways that protect human health and the environment, as well, as making materials available for remanufacturing.
- Making funding available with the goal of tripling Michigan's recycling rate. The funding would cover:
 - Local Materials Management Planning,
 - o Recycling infrastructure development,
 - o Development of markets for recyclable materials, and
 - Education to help residents use recycling systems effectively.

Whereas, the City of Hancock is committed to supporting a circular bio-economy by utilizing relationships with waste management contractors, university researchers, industrial and non-profit partnerships, and local community stakeholders to pioneer methods of materials management for our region. The City of Hancock will strive to recognize the intrinsic values of materials and seek to conserve, reclaim, and reinvest them to the highest level possible. The City of Hancock shall encourage a culture of consideration, for itself and its constituency, when procuring materials, in its practices, by soliciting expert advice, when reviewing budgets, and by seeking funding in support of these goals.

Whereas, the City of Hancock recycles less than 28% of its municipal waste stream and would benefit from a fresh take on waste, funded planning, and state grants, including funding for:

- Improved recycling infrastructure and services
- Public education

Whereas, Public Act 588 enrolled in the 2018 Legislative makes annual funding available to support the amendments proposed to Michigan Solid Waste Laws;

Accordingly, it is hereby resolved that the City of Hancock supports the substantial update of Michigan solid waste laws, Part 115, for the advancement of local, county, regional, and state recycling goals and county materials management planning.
