- The City Manager was asked by a resident what the Naming Procedures of City Property were for the City of Hancock. We do not have any formal process or procedures. If the Council would like to consider establishing procedures, we can do some research and gather some sample policies from other communities.
- DPW Director John Erickson gave an update on the DPW activities, including the storm sewer work, blacktop patches and winter equipment preparation.
- Chief Wayne Butler gave an update on the police department, they have passed their first in-person LEIN audit; he reviewed a couple recent incidents and events they have provided support to; and they are in the process of completing their weapons qualifications.
- Clerk/Treasurer Linda Kalinec mentioned they have started the audit process, Christina plans to be here the end of the month, beginning of October. The overseas ballots are required to be sent by this Saturday, September 24th, they are usually emailed. We received new workstation desks and walls from MTU, which has been placed in the area coming into the council chambers, it has really improved the organization and look of this area.
