## CITY OF HANCOCK

## CITY ORDINANCE #275

An ordinance establishing rules and regulations on Feeding Birds and Waterfowl. THE CITY OF HANCOCK ORDAINS:

Section 1. Purpose

It has been determined that the presence of large numbers of certain species of birds and waterfowl cause a public health nuisance by contaminating beaches, shorelines, parks, buildings, sidewalks and pathways used by the public. Accordingly, this ordinance is adopted to prevent such conduct as may attract and concentrate certain species on and around Portage Lake and Waterway, beaches, shorelines, parks, highway, buildings, sidewalks and streets and pathways in the City of Hancock.

Section 2. Definitions

The following words, terms and phrases, when used in this ordinance, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning.

Domestic waterfowl means nonnative ducks and geese not retained in agricultural operations.

Feed or feeding means the act of feeding or furnishing of food or other substance to any form of bird and/or waterfowl species regulated by this ordinance.

Migratory waterfowl means ducks, and geese, native to North America.

Pigeon means any of the various birds of the widely distributed family of columbidae, characteristically having plump bodies, small heads and short legs, especially the rock dove or any of its domesticated varieties.

Section 3. Prohibition on Feeding

A. Migratory and domestic waterfowl

- 1. No person shall feed, cause to be fed or provide food for domestic or migratory waterfowl located in the City of Hancock.
- 2. No person shall create or foster any condition, or allow any condition to exist or continue, which results in a congregation of congestion of domestic or migrating waterfowl in the City of Hancock.
- B. Pigeons
  - 1. No person shall feed, cause to be fed or provide food for pigeons located in the City of Hancock.
  - 2. No person shall create or foster any condition, or allow any condition to exist or continue, which results in a congregation or congestion within the City of Hancock.

Section 4. Songbird Feeders.

Within the boundaries of the City of Hancock in which feeding of waterfowl and pigeons is prohibited, birdfeeders may be erected and maintained for other avian species. Section 5. Enforcement

The City Police Department and other city staff as designated by the City Manager are hereby authorized and directed to enforce this ordinance.

## Section 6. Penalties.

Any person violating any provision of this ordinance is guilty of a misdemeanor punishable by a fine not exceeding one hundred dollars (\$100) or by imprisonment in the county jail for a period not exceeding ninety (90) days, or in both such fine and imprisonment.

Section 7. Invalidity

If part of this ordinance shall be held invalid such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this ordinance.

<u>Section 8.</u> This ordinance was introduced by the city council of the City of Hancock, Houghton County, Michigan, on the 21st day of April, 2010.

## CITY ORDINANCE #276

## An ordinance establishing rules and regulations on dog restraint and dog

defecating.

# THE CITY OF HANCOCK ORDAINS:

Section 1. Purpose

It has been determined that the owning or harboring of a dog in the City of Hancock that is not restrained or under control of the owner or allowing dogs to deposit wastes outside the owners property control is deemed a public nuisance. It is deemed by the city that the ownership of a dog is a privilege which carries with it responsibilities to the city and its residents with regard to the custody of said dog.

Section 2. Definitions

The following words, terms and phrases, when used in this ordinance, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning.

Owner means when applied to proprietorship of a dog shall include every person having a right of property in such dog, and every person who keeps or harbors such dog or has it in his or her care, and every person who permits such dog to remain in or about any premises occupied by him or her.

Reasonable control means keeping a dog on a suitable leash or under the oral control of the owner or custodian or some other person with the permission of the owner or

custodian, in all cases other than while upon private property, or unless the dog is confined in a closed automobile, or shipping receptacle.

Section 3. Restraint Required

A. All dogs shall be secured by a leash under control of a responsible person or obedient to that person's commands.

Section 4. Animal Waste

The owner of every dog shall be responsible for the prompt removal of any defecation/ excreta deposited by their dog on public sidewalks, streets, highway, parks, beaches, recreation areas, or other property not under ownership of the dog's owner. Section 5. Enforcement

The City's Police Department and other city staff as designated by the City Manager are hereby authorized and directed to enforce this ordinance.

### Section 6. Penalties

Any person violating any of the provisions of this ordinance is guilty of a misdemeanor punishable by a fine not exceeding one hundred dollars (\$100) or by imprisonment in the county jail for a period not exceeding ninety (90) days, or both such fine and imprisonment.
