The national teams include the renowned **Sculptora Borealis**, whose team members have won the National Snow Sculpting title four times, in six appearances over the last seven years, and **Team USA**, winners of the bronze medal at the 1998 Nagano Olympics and two-time National Snow Sculpting title winners.

UPCOMING MARCH BOARD OF REVIEW MEETINGS

Each year, before the March Board of Review meetings, information notices are mailed to property owners.

What do these notices include? They include:

- Taxable Valuation
- State Equalized Value
- Property Classification
- Percent of exemption as a Principal Residence
- If there was an Ownership transfer
